CLAUSE 2

SCOPE OF THE MOU

- 2.1 The budding B.Sc., & M.Sc., Biochemistry students from the institutions could play a key role in technological upgradation, innovation, and competitiveness of an industry.
- 2.2 Curriculum Design: Second Party can give valuable inputs to the first Party, and suitably customize the curriculum and in teaching/training methodology so that the students fit into the industrial scenario meaningfully.
- 2.3 Industrial Training & Visits: Industry and Institution interaction will give an insight into the latest developments/requirements of the industries; Second Party shall permit the Students of the First Party to visit its Project and Training Institute and also involve in Industrial Exposure Training (IET), field visit, & Outdoor Training service provided to students through this association which will build confidence and prepares the students to have a smooth transition from academic to working career.
- 2.4 **Guest Lectures:** Second Party might extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends.
- 2.5 Both Parties shall obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.
- 2.6 Collaboration with BioXplora can organize conferences and Workshops.
- 2.7 Collaboration with BioXplora can conduct some diploma / certificate courses and training programs.
- 2.8 This MOU does include the reimbursement of funds between Party A and Party B.



VALIDITY

- This Agreement will be valid for a period of **Three years** until it is expressly terminated by either Party during which period the first party or second party, as the case may be, can be extended on mutual consent.
- If the agreement is terminated prior to the MoU expiration, any action on the part of the First Party or Second Party, after the termination of this Agreement by way of communication, correspondence, etc., shall not be construed as an extension of this MoU.
- Both Parties may terminate this MoU upon 30 calendar days notice in writing. In the event of Termination, both parties must discharge their obligations.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MoU as independent entities, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations, or create any obligation or liability, express or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to or to extend any liability on behalf of the other Party.

MEMORANDUM OF UNDERSTANDING

THIS AGREEMENT is made and entered into this 11th day of September 2023 (the "Effective Date"). By and Between M/s. PR Academy, a Coaching Center exclusively for Advanced Commerce Professional Course having its Registered Office at 62/2, II Floor, Rajaji Road, Ram Nagar, Coimbatore and Which term and expression shall unless it is repugnant to the context or meaning thereof mean and include their heirs, administrators, and legal representatives (hereinafter referred to as "The Academy") of the ONE PART.

AND

M/s. Muthayammal College of Arts & Science which comes under Muthayammal Educational and Charitable Trust (MECT), a Trust formed and registered under the provisions of the Trust Act, having its registered office at Vengayapalayam, Kakkaveri (PO), Rasipuram (Tk), Namakkal (Dt), Tamil Nadu – 637408. Which term and expression shall unless it be repugnant to the context or meaning thereof mean and include its successors and assigns (hereinafter referred to as "The College") of the OTHER PART.

RECITALS:

The Purpose of this MoU is with reference to conducting Coaching Classes for students who have completed 12th Standard or Equivalent and have been continuing their UG / PG in "The College". All the activities and initiatives delivered by "The Academy" will be student centric.

AND

WHEREAS, The Academy has the requisite expertise, specialized knowledge and experience in this field and has offered these services to The College AND

WHEREAS "The College" has agreed to appoint "The Academy" for Coaching and Teaching with the prospective talent in the agreed Territory (hereinafter referred to as the "Academic Services") more of particularly set out hereinafter, on the terms and conditions stipulated hereinafter. For this Agreement, the

term "Territory" referred to herein shall mean and include the territory of Rasipuram in Namakkal District. In addition, New Territory may be added to the existing list of Territory, as may be mutually agreed upon by both "The College" and "The Academy" in writing from time to time.

NOW THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both "The Academy" and "The College" hereby acknowledge, "The Academy" and "The College", hereby agree to sign a Memorandum of Understanding (MoU).

1. APPOINTMENT:

- 1.1"The College" hereby appoints "The Academy" to render Coaching Services and "The Academy" hereby accepts the same upon the terms and conditions hereinafter set forth.
- 1.2 "The Academy" shall depute qualified faculties for teaching at the College premises or such other place as decided by "The College" or by the Both Parties.

- 2.2 The duration of MoU shall be for a period of 3 years effective from 11th September 2023 to 10th September 2026.
- 2.3 During its tenancy, the MoU may be extended or terminated by prior notice of not less than Six months by either party. However, termination of the MoU will not in any manner affect the interests of the students who have been admitted to pursue a program under the MoU.
- 2.4 Any clause or article of the MoU may be modified or amended by the mutual agreement.

3. DUTIES AND SERVICES:

- 3.1 The Motto of the "The Academy" and its Duties and Responsibilities are to help "The College" for Coaching, Teaching and Course Consultancies for CA / CMA / ACCA.
- 3.2 "The Academy" will conduct fortnightly and Monthly tests through "The College" based on the topics that are covered during classes as per its Schedule.

- 4.5 The Collection of Tuition Fees from the students will strictly be under the purview of "The College". The principal (or) The Dean -Administration / HOD of Commerce of the College ("The College") will be the final authority and responsibility for the same.
- 4.6 No other fees either in cash or kind from any student shall be collected by any staff of "The Academy" or its representatives.
- 4.7 100% Tuition Fees shall be paid in advance before the commencement of the Coaching, or it shall be paid in three installments before the completion of the course.

7.1 "The Academy" and "The College" shall be bound to observe absolute secrecy, both during the term of the Agreement and after its termination, with regard to any confidential information, trade secrets or other proprietary information relating to the business of the both or its subsidiaries, affiliated, associated and related individuals, companies, institutions, organizations etc., insofar as this is not in contravention of any statutory regulation or court order.

8. GENERAL TERMS AND CONDITIONS:

- 8.1 Headings: Headings and subheadings are for convenience only and shall not be deemed to be a Part of this Agreement.
- 8.2 Amendments: This Agreement may be amended or modified, in whole or in part, only by an instrument in writing signed by all parties hereto.
- 8.3 Notices: Any Notices or other communications required hereunder shall be in writing and shall be deemed given when delivered in person or when mailed, by certified or registered first class mail, postage prepaid, return receipt requested, addressed to the parties at their addresses specified in the preamble to this Agreement or to such other addresses of which a party shall have notified the others in accordance with the provisions of this Article7.3.
- 8.4 Activity: Conduct no such parallel activity which may be prejudicial to the interest of both the parties.
- 8.5 Disputes: Any dispute arising with regard to any aspect of this agreement shall be settled through mutual consultations and agreements by the parties of the agreement.
- 8.6 Counterparts: This Agreement may be executed in two or more counterparts, each of which shall constitute an original and all of which shall be deemed a single agreement.
