

INSTRUCTIONS TO THE AUTHORS

GENERAL

AIM AND SCOPE

MCAS JOURNAL OF RESEARCH (MCAS J.Res) is dedicated for publishing excellent and cutting edge innovative research articles related to all fields of Arts and Crafts, Biological sciences, Computer sciences and physical sciences will be considered for publication. The manuscripts intended for publications shall be rigorously examined and selected on the basis of quality and originality of the work.

EDITORIAL POLICY

Research papers submitted to MCAS JOURNAL OF RESEARCH must be original, have never been published or submitted for publication elsewhere. In case of coauthored papers it will be the responsibility of the corresponding author of the paper to ensure that the manuscript has been approved by all the co-authors. In addition, it is also the responsibility of the corresponding author to ensure that a paper emanating from a particular institution has obtained the necessary approval of that institution. Editorial board has the sole right to publish or not to publish any paper and its decision is final concerning publication of any paper.

Manuscripts should be sent to the Editor-in-Chief, MCAS JOURNAL OF RESEARCH. Authors are advised to submit soft copies of their manuscripts to the e-mail address editormcasjr@gmail.com. If there is any difficulty in submitting a soft copy online, they can send the softcopy to rdcell@muthayammal.in. Papers should be typed in MS-Word, 1.5 spacing using Times New Roman, font size 12. The length of the articles should be 4000 words or less. Though, longer research papers may be considered where necessary.

GUIDELINES FOR SUBMISSION OF MANUSCRIPTS

Manuscripts submitted for publication must be original and have not been published in another journal. Manuscripts should be single spaced throughout with enough margins on all sides of the pages. High quality original figure(s) and photograph(s) must be submitted along with the manuscript. However, corresponding author is encouraged to keep a copy of the manuscript for checking against the proofs.

Manuscripts that do not comply with the requirements for content and format will be rejected. Authors should ensure that their English is polished before submission to avoid delay in publication and proof reading.

- Use active voice whenever feasible and write in first person
- Use British spellings and grammar
- Research theses/reports are usually written in style not suitable for publication in MCAS JOURNAL OF RESEARCH. Chapters from these theses may need to be condensed, reformatted and revised before being submitted as manuscripts.

TITLE

The title of the paper should be brief, specific and informative. This is to be followed by the name (s) of the author (s). Address of the institution should follow the text. The name and address including e-mail, phone and fax number of the corresponding author should be indicated.

ABSTRACT

A brief abstract not exceeding 250 words of the principal points and important conclusions should be after the address without additional paragraphs and indentation.

KEY WORDS

There should be 3-5 key words indicating the contents of the paper below the abstract.

TEXT

The text of the paper should be divided into sections starting with the “Introduction”, “Materials and Methods”, “Results” and ending with “Discussions”. Introduction should be brief and limited to the statement of the problem and experiment. The literature review should be pertinent to the problem under study. Materials and methods should include relevant details on the nature of material, experimental design and the statistical methods used. Results and discussions can be combined to avoid repetition. Numerical results should be shown in the tables and same may be repeated in the text.

REFERENCES

References should be arranged alphabetically by author's name followed by initial(s), year, title, journal, volume, number of the volume if any and the pages of the paper. References should be cited in the text by authors name and years, i.e. Harris (1989) and Patel et al. (2004) etc.

For references in the text, give full surnames for papers by one or two authors, but only the surname of the first author, followed by 'et al'. The 'et al.' should be italicized. List multiple citations in chronological order (e.g Harris, 1990; Patel 1999; Edwards et al., 2000), using a semicolon to separate each reference.
