

Further, Molecular Connections agrees to pay Rupees Twenty-TwoThousand Three hundred and Fifty only per month (Rs. 22,350 i.e., E.B Bill 14,040, Water usage charge 1000, Internet usage 5310, Maintenance charge 2000) to a total of Rupees one lakh Eleven thousand seven hundred and fifty only (1,11,750) for the period of 5 months (20<sup>th</sup> June 2022 to 19<sup>th</sup> November 2022) towards the usage of power, Internet usage, office maintenance, water usage and other common facilities as agreed between the parties.
- 9. Once Molecular Connections commences its operations in new facility, Molecular Connections agrees to pay a consolidated maintenance charge of <a href="Rs. Five thousand">Rs. Five thousand (5000)</a> per month towards water usage and other common maintenance facilities. Also the College will provide a separate power meter to Molecular Connections, and Molecular Connections shall pay the consumptions charges as per the meter at the prevailing TNEB tariff charges.
- 10. All the Intellectual Property related to the work done within the MOLECULAR CONNECTIONS facility shall exclusively belong to MOLECULAR CONNECTIONS, no other will have any rights on

the same. The college provides MOLECULAR CONNECTIONS the exclusivity and agrees not to allow any other entity which competes with MOLECULAR CONNECTIONS to set up a similar facility.

- 11. MOLECULAR CONNECTIONS shall engage students of the colleges in various ways
  - As interns— either full time or part-time
  - As employees—full time
  - On specific projects on a contract basis either full time or part-time

Standard terms and conditions of MOLECULAR CONNECTIONS shall apply in each of the above cases. All arrangements of work shall be strictly between individual student candidates and MOLECULAR CONNECTIONS.

The college shall support to assist students, interns, employees and contractors who are engaged with MOLECULAR CONNECTIONS's work for their stay. Also, College shall support Molecular Connections employees or associates with food, beverages, transportation at subsidized rates. All payments related to this will be done by the respective individuals appointed for Molecular Connections activities to the College directly in this regard.

Any engagement of students or ex-students of the College - as interns, as employees or as contractors for specific projects, is at absolute discretion of MOLECULAR CONNECTIONS. Further, MOLECULAR CONNECTIONS at its own discretion can hire and deploy candidates from outside other than students or ex-students of MUTHAYAMMAL college.

MOLECULAR CONNECTIONS shall do the same in consultation with the College and in a manner which does not impact academic schedule of any students who may still be studying a course in the College. MOLECULAR CONNECTIONS may conduct tests, interviews and other assessments to judge the suitability of any candidate at its absolute discretion.

- 12. MOLECULAR CONNECTIONS shall consult with College from which streams of study and from which years of study, it can engage the Students. The college shall also facilitate engaging its alumni by MOLECULAR CONNECTIONS. MOLECULAR CONNECTIONS shall appropriately collaborate with the college Faculty to help prepare students better for industry requirements. These inputs could include syllabus suggestions, workshops with faculty on industry practices etc.
- 13. The MOU shall be valid initially for a period of two (2) years and can be extended on mutual consent.
- 14. If the lease agreement is terminated prior to the MOU expiration, the scope of the MOU shall stand reduced to that extent, but other aspects of the MOU can continue.
- 15. Both parties shall work in good faith and in close collaboration to ensure objectives of this MOU are achieved.
- 16. A separate lease/rent agreement shall be executed between the Parties upon completion of furnished office space as per agreed terms and conditions.
